#### **Additional Conditions**

### A. Water (Prevention and Control of Pollution) Act, 1974

- Industry shall operate and maintain the effluent treatment plant regularly and ensure the treated effluent quality within prescribed standards all the time. Industry shall not discharge effluent outside the premises in any circumstances. Zero discharge condition shall be maintained all the time.
- 2. Industry shall comply with the code of practice (rain guns, catch drains, settling pit, CCTV Camera, plantation wind breaking wall wheel wash system pucca approach road etc.) for coal washeries issued by Central Pollution Control Board.
- 3. Industry shall install separate digital meter for measurement of ground & surface water used.
- 4. Industry shall ensure maximum reuse of non-potable water.
- 5. All the internal roads shall be maintained pucca. Industry shall adopt good housekeeping practices. The roads shall be regularly cleaned. Avenue plantation shall be developed along the roads.
- 6. Industry shall comply with the provisions of notification dated 21.05.2020 issued by MoEF & CC regarding linkage of rejects.
- 7. Industry shall take effective steps for safe disposal of solid wastes and sludge & reject.
- 8. All the solid waste industrial and domestic shall be disposed off in environment friendly manner as per rule.
- 9. Industry shall comply with Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 (as amended upto date).
- 10. Transportation of coal by road shall be carried out by covered trucks. Industry shall ensure transportation through properly covered vehicles. Effective measures such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of particulates such as roads, belt conveyors, loading/unloading and transfer points. It shall be ensured that the ambient air quality parameters conform to the norms prescribed by the Central/State Pollution Control Board. Industry shall ensure transportation of coal/reject with mechanically covered trucks by 12/07/2023.
- 11. Industry shall enhance the capacity of rainwater-harvesting system and residential area (if any) for recharge of ground water. The rainwater-harvesting technique shall be incorporated right from the design stage of all structures.
- 12. Industry shall make proper arrangement for storage of raw coal, washed coal and rejects
- 13. Extensive in tree plantation shall be carried out in the open areas

- available within and around the plant premises in during monsoon season. Fruit bearing species like mango, tamarind, guava etc. shall be given preference in this regard.
- 14. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) Amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year
- 15. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Sanjay Verma, Plant Head of M/s ACB (India) Limited, Village Beltekri, Post Dipka, Tehsil Katghora, District Korba (C.G.).
- 16. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.
- 17. In case, if the capital investment is increased by such amount that the total investment exceeds the range for which renewal fees has been paid, the industry shall have to pay the difference amount of renewal fees for the corresponding block years.
- 18. In case, the prescribed fee payable is amended in future, the industry shall be liable to pay the difference amount for corresponding block years.

## B. Air (Prevention and Control of Pollution) Act, 1981

- 1. Industry shall ensure the emission of particulate matter within the prescribed all the time.
- 2. Industry shall comply with the code of practice (rain guns, catch drains, settling pit, CCTV Camera, plantation wind breaking wall wheel wash system pucca approach road etc.) for coal washeries issued by Central Pollution Control Board.
- 3. Ambient air quality within premises shall be within latest prescribed limit.
- 4. All the solid waste industrial and domestic shall be disposed off in environment friendly manner as per rule.
- 5. All the internal roads shall be maintained pucca. Industry shall adopt good housekeeping practices. The roads shall be regularly cleaned. Avenue plantation shall be developed along the roads.
- 6. Industry shall take effective steps for safe disposal of solid wastes and sludge & reject.
- 7. Industry shall comply with Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 (as amended upto date).

- 12. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) Amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.
- 13. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Sanjay Verma, Plant Head of M/s ACB (India) Limited, Village Beltekri, Post Dipka, Tehsil Katghora, District Korba (C.G.).
