With reference to your above application, consents under section 25 of the Water (Prevention and Control of Pollution) Act, 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act, 1981 are hereby renewed **from date of issue of this letter to 28/02/2026**, subject to the fulfillment of the terms and conditions incorporated in the water consent letter no. **94/TS/CECB/2008 Raipur, dated: 08/01/2008** and air consent letter no. **96/TS/CECB/2008 Raipur, dated: 08/01/2008** and subsequent renewal(s)/amendment(s) issued by the Board and additional conditions mentioned below.

## **Additional Conditions**

### **A. Water (Prevention and Control of Pollution) Act, 1974**

1. Industry shall operate and maintain the effluent treatment plant regularly and ensure the treated effluent quality within prescribed standards all the time. Industry shall not discharge effluent outside the premises in any circumstances. Zero discharge condition shall be maintained all the time.
2. Industry shall comply with the code of practice (rain guns, catch drains, settling pit, CCTV Camera, plantation wind breaking wall wheel wash system pucca approach road etc.) for coal washeries issued by Central Pollution Control Board.
3. Industry shall make arrangements like installation of digital water meter separately for under ground as well as surface water, reuse of non potable water etc. as per NGT order dated 15/11/2022 on OA no. 392/2022 for use of water.
4. Industry shall ensure the transportation of the raw coal, washed coal and reject etc. through mechanically covered vehicles by 12/07/2024.
5. Industry shall ensure maximum reuse of non-potable water.
6. All the solid waste industrial and domestic shall be disposed off in environment friendly manner as per rule.
7. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
8. Industry shall comply with the provision of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 from the Board and comply with the rule.
9. Industry shall ensure transportation of coal reject/middlings / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall ensure transportation of coal in mechanically covered vehicles.
10. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) Amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.
11. Extension of tree plantation shall be carried out in the open areas available within and around the plant premises in during monsoon season. Fruit bearing species like mango, tamarind, guava etc. shall be given preference in this regard.
12. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Ram Phal Moar, Plant Head of M/s ACB (India) Limited, Patwari Halka No. – 21, Village – Dipka, Post - Dipka, Tehsil – Katghora, District - Korba (C.G.).

13. In case, if the capital investment is increased by such amount that the total investment exceeds the range for which renewal fees has been paid, the industry shall have to pay the difference amount of renewal fees for the corresponding block years.
14. In case, the prescribed fee payable is amended in future, the industry shall be liable to pay the difference amount for corresponding block years.
15. Chhattisgarh Environment Conservation Board reserves the rights to revoke the consent / renewal of consent at any time for any violation/non-compliance.

## **B. Air (Prevention and Control of Pollution) Act, 1981**

1. Industry shall ensure the emission of particulate matter within the limit prescribed by the board all the time. Industry shall provide suitable air pollution control arrangement at different points to control fugitive emission. Industry shall also maintain the ambient air quality within the factory premises within prescribed limit.
2. Industry shall comply with the code of practice (rain guns, catch drains, settling pit, CCTV Camera, plantation wind breaking wall wheel wash system pucca approach road etc.) for coal washeries issued by Central Pollution Control Board.
3. Industry shall ensure the transportation of the raw coal, washed coal and reject etc. through mechanically covered vehicles by 12/07/2024.
4. All the solid waste industrial and domestic shall be disposed off in environment friendly manner as per rule.
5. All the internal roads shall be maintained pucca. Roads shall be cleaned regularly. Dust, muck and sludge collected from roads shall be disposed properly.
6. Industry shall comply with the provisions of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 from the Board and comply with the rule.
7. Industry shall ensure transportation of coal reject/middlings / waste by properly covered vehicles. Vehicles used for transporting the wastes / sludge shall be covered with tarpaulins and optimally loaded. Vehicular emissions shall be kept under control and regularly monitored. Industry shall ensure transportation of coal in mechanically covered vehicles.
8. Industry shall follow notification, order, guideline issued by MoEF & CC for use of middlings & rejects.
9. Industry shall submit Environment Statement to this Board as per provision of Environment (Protection) Amendment Rule, 1993 for the previous year ending 31st March on or before 30th September every year.
10. Extension of tree plantation shall be carried out in the open areas available within and around the plant premises in during monsoon season. Fruit bearing species like mango, tamarind, guava etc. shall be given preference in this regard.

11. This renewal of consent is being issued under the "Scheme of Auto-Renewal of Consent" of the Board issued vide office order no. 5937 dated 29/01/2018 as per self certificate submitted by authorized signatory Mr. Ram Phal Moar, Plant Head of M/s ACB (India) Limited, Patwari Halka No. – 21, Village – Dipka, Post - Dipka, Tehsil – Katghora, District - Korba (C.G.).
