Upon such payment by the company, the Government shall execute and do all such acts, deeds, matters and things as may be necessary or proper for effectively vesting the said land in the company and giving the company an absolute title thereto subject to the payment of an accessment or record thereto subject to the payment of an assessment or ground rent as here in after provided.
- 3. The terms upon which the said land shall be held by the company are:
- (a) That the land shall be used for coal based Fertilizer Factory and its allied purposes or for purposes incidental thereto and for other purposes connected therewith.
- b)That the company shall pay to the Government annually the appropriate assessment or ground rent, as the case may be, on the land, which shall be liable to revision at an general revision of the land revenue settlement:
- (c) That the Company shall not except with the pre-vious sanction of the Government use the land for any purpose other than that specified above:
- (d) That the time within which the land be used for the construction of Coal based Fertilizer Factory and its township for purposes incidental thereto or an for other purposes connected therewith be completed, shall not exceed three years from the date of transfer of the land to the Company.
