With reference cited (2) above, the management of "M/s. APL Apollo Tubes Limited." had requested for the Fire safety compliance report from our department. In this regard the District Fire Officer, Kolar Fire Station, Kolar has re-inspected on 27-10-2023 and submitted the report to issue Fire safety Compliance report. Since, you have Major Accident Hazard Factory recommendation to take two Fire Hydrant Officer/Operator to avoid explosive non compliance.

Under the above circumstance the Karnataka Fire & Emergency Services Department is issuing the "Fire Safety Compliance Report" to "M/s. APL Apollo Tubes Limited., Plot No 53, Part-1, 4<sup>th</sup> Phase, Sy No. 28-33, Kurundahalli Village, Kasaba Hobli, Malur Taluk, Kolar District – 563 130". subject to proper maintenance of fire fighting installations in the good working conditions and impart the 40% training part within 90 days from the date of issue of this report. **"This report is valid up to 17-10-2024 and is renewable without fail".** (Note: The separate NOC has to be obtained for the storage of LPG from the department within 30 days from the date of issue of this report)
