- Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 15/06/2020 to the Board.
- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

Specific Conditions:

## (M/s NCML Basti Pvt. Ltd.)

Unit should obtain consent to operate from the Board before starting storage of wheat in the ware house.

2- Unit should not discharge any kind of industrial effluent.

- 3- Unit should install septictank-soakpit for the treatment of domestic effluent generated from ware house.
- 4- Unit should be operated in such a way that any adverse effect should not observe on the near by human habitation as well as environment.

5- Unit should develop green belt at 33% of total plot area for conservation of environment.

6- Unit should make separate drain for discharge of storm water.

7- Unit should install rain water harvesting system for recharge of under ground water.
 8- For expansion in storage capacity of ware house or change in storage process of wheat

separate NOC from the Board shall be required.

09- Disposal of solid waste generated from the ware house shall be made by unit as provisions made under solid & other waste management rules, 2016.

10- Height of the stack attached to exhaust of 500 KVA silent gen set shall be minimum 0.2KVA

from the nearest roof top.

11- Unit should install technically adequate Air Pollution Control System at all the sources of emission.

12- Unit should ensure regular operation and maintenance of APCS installed, so that emission should meet the standards as stipulated by Board and should not adversely affect the near -bye environment.

13- Unit should submit on site disaster management plan dully approved by dept. of factories within 06month to the Board.

14- Unit should adopt all necessary measures at site for control of pollution.

- 15- Unit should be bound to comply with the provision made in Environment (Protection) Act, 1986.
- 16- Unit should ensure submission of environmental statement upto 30 September or before for every financial year.

17- Unit should ensure submission of all licenses/NOC obtained from other concerned department to Board within 03 months.

18- Unit should not store any hazardous material or hazardous chemical within the ware house

promises.

19- Unit should make pucca road within ware house premises for control of fugitive emission due to movement of vehicles.

20- NOC issued is valid only for storage of wheat without any processing.

21- Unit should obtain NOC from Central Ground Water Authority (C.G.W.A.) for abstraction of ground water and submitted the same to the Board within 06 months.

Please note that consent to Establish will be revoked, in case of, non compliance of any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 16/07/2019 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
