WHEREAS, Company is engaged in the business of biomass pellet production utilizing organic waste including Napier grass.

WHEREAS, Farmer is engaged in agricultural activities and possesses the necessary resources, land, and expertise to cultivate and supply Napier grass to Company.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties agree as follows:

1. Purpose of Agreement

1.1 Company engages Farmer for the cultivation, harvesting, and supply of Napier grass (*Pennisetum purpureum*) for utilizing in the company's biomass pellet plant situated at village Bhulawai, Chandausi, Sambhal. U.P.

2. Responsibilities of the Parties

2.1 Farmer's Responsibilities:

- Farmer shall cultivate and maintain the Napier grass on the land specified in Annexure A, which is attached hereto and incorporated by reference.
- Farmer shall ensure that the Napier grass is grown, harvested, and delivered to Company in good quality and condition.
- Farmer shall use reasonable farming practices to protect the Napier grass from pests, diseases, and environmental factors.
- Farmer shall provide necessary labor, equipment, and inputs for cultivation and maintenance.

2.2 Company's Responsibilities:

- Company shall purchase the Napier grass from Farmer at the prices and quantities specified in Annexure B.
- Company shall provide Farmer with technical guidance and support as needed for the successful cultivation and harvest of Napier grass.
- Company shall inspect the Napier grass upon delivery and reject any Napier grass not meeting the agreed-upon quality standards.
- Company shall make payments to Farmer for Napier grass supplied within 45 days of receipt and acceptance.


3. Payment and Price

3.1 The price for the Napier grass shall be as specified in Annexure B.

3.2 Payments shall be made by Company to Farmer through the bank account specified by Farmer.
