HPCL-Mittal Energy Limited (HMEL) has submitted a copy of NOC given by its Managing Director and Chief Executive Officer (Mr. Prabh Das) to transfer the above EC in the name of new company. Copy of undertaking signed by DGM (Mr. Sanket Thapar) of M/s. HMEL Organics Private Limited has been submitted to abide by the terms and conditions prescribed in the environmental clearance dated 24<sup>th</sup> March, 2022.

**7.**As per the relevant provisions of the EIA Notification, 2006, the environmental clearance to the project for installation of 300 KLPD Grain based Ethanol Plant by M/s.
