With reference to our previous correspondence dated 15-03-2024, we are writing to formally submit the requested documents pertaining to the mutation of land in favor of Ess Dee Aluminium Ltd (hereinafter referred to as "ESS DEE").

- 1. As Per the provisions outlined in Clause 1 of the Letter dated April 16, 2024, and in accordance with the affidavit submitted on March 15, 2024, we direct your attention to specific pages 51 through 66. These points delineate the merger scheme between India Foils Ltd and Ess Dee Aluminium Ltd. Furthermore, we highlight the amalgamation/merger order dated September 30, 2010, which is detailed within the aforementioned pages. It is crucial to emphasize that these documents have been duly lodged on the Ministry of Corporate Affairs (MCA) website, thus confirming their authenticity. Any further inquiries regarding these documents will be addressed with precision.
- 2. In reference to Clause 2 of the Letter dated April 16, 2024, we hereby provide an elucidation concerning the recent submission of the petition for land mutation in favour of Ess Dee Aluminium Ltd over Shakambhari Ispat & Power Limited.

To initiate, it is imperative to comprehend the tenets of the Insolvency and Bankruptcy Code of 2016. Enacted in 2016, however, the Indian government's intent is unequivocal: to rejuvenate struggling industries. This initiative is critical as it aims to resuscitate financially distressed companies and thereby fortify the nation's economy.

Now, turning to the matter concerning Ess Dee, State Bank of India filed an application for the initiation of Corporate Insolvency and Resolution Process under Section 7 of the Insolvency and Bankruptcy Code, 2016, read with Rule 4 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016.

The Corporate Debtor was admitted into Corporate Insolvency Resolution Process (CIRP) via an Order dated February 14, 2020, issued by this Adjudicating Authority. Ms. Deepika Bhugra Prasad was appointed as the Interim Resolution Professional (IRP) for the Corporate Debtor.

Subsequently, Ms. Deepika Bhugra Prasad was appointed as the Interim Resolution Professional (IRP) for the Company, and in the initial meeting of the Committee of Creditors (COC) held on March 18, 2022, the IRP was appointed as the Resolution Professional ("RP") of the Company, a decision confirmed by the Hon'ble NCLT. As of the commencement date of CIRP, the powers of the Company's board of directors were suspended and were exercised by the RP, in accordance with the provisions of the IBC, 2016.

Furthermore, in the absence of any approved Resolution Plan by the COC members, the natural consequence for the Company was liquidation, and the COC members passed a Resolution for the liquidation of the Company with a voting share of 84.78%. Consequently, the Hon'ble NCLT initiated the liquidation of the Company via an Order dated October 08, 2021, and appointed Ms. Deepika Bhugra Prasad as the Liquidator of the Corporate Debtor (Liquidation Process).

The Liquidator published the E-auction Sale Notice dated August 04, 2022, and its subsequent addendums, inviting bids for the sale of the Company as a "going concern" and on a piecemeal basis, as per Regulation 6(2)(b) of the 2016 Regulations. Pursuant to the E-Auction process conducted by the Liquidator on August 26, 2022, M/s Shakambhari Ispat & Power Limited (SIPL) was declared as the successful bidder for the Company.

Consequently, a letter of intent dated September 06, 2022, was issued by the Liquidator to SIPL, and the entire sale consideration was received by the Liquidator until September 15, 2022. Accordingly, the Liquidator issued a sale certificate dated September 28, 2022, and the Company was sold as a **"Going Concern"** as per Regulation 32(e) read with Regulation 32A of Insolvency & Bankruptcy Boards of India (Liquidation Process) Regulations, 2016.

Thus, a sale certificate dated September 28, 2022, was issued by the Liquidator, wherein the Company was sold as a **"Going Concern"** as per Regulation 32(e) read with Regulation 32A of Insolvency & Bankruptcy Boards of India (Liquidation Process) Regulations, 2016, thereby absolving the sale of the Company from any liability or encumbrances as per Regulation 53 of the IBC Code.

Furthermore, the NCLT, via its order dated February 24, 2023, approved the acquisition of the Company as a "Going Concern" along with the grant of certain reliefs, concessions, waivers, etc., as per the application under Section 35(10(n) and Section 60(5) of the IBC, 2016, read with Regulation 32A and 32(e) of Insolvency & Bankruptcy Boards of India (Liquidation Process) Regulations, 2016, filed by M/s Shakambhari Ispat & Power Limited (SIPL).

We have provided this comprehensive account to elucidate the company's history. Shakambhari acquired Ess Dee and established it as its wholly-owned subsidiary. However, Ess Dee maintains its distinct existence, hence the financial support and establishment provided. Consequently, the property and title are held under Ess Dee's name, and following the merger, it falls under India Foils Ltd. Hence, we seek the mutation to be under Ess Dee's name.

7. Furthermore, we wish to address Clause 3 of the aforementioned Letter dated April 16, 2024. As the newly appointed manager of the commercial unit spanning an area of 17.33 acres, comprising 62 plots in mouza-Hoera, J.L No.-1, under the jurisdiction of the BL & LRO, Mogra Chinsurah, we express our lack of awareness regarding the absence of necessary permits and approvals for land conversion prior to our assumption of duties on February 24, 2023.

We fully recognize the significance of obtaining the requisite land conversion approvals for the aforementioned unit. Consequently, we formally request your assistance in procuring the necessary permits and approvals to ensure that the commercial unit aligns with all legal requirements.

8. In accordance with Clause 4 of the letter, please find enclosed an original authorization letter empowering Mr. Jeetendra Kumar Pandey to liaise with the BL&LRO, Chinsurah-Mogra for the registration and mutation of land.
