Sub: - Submission of documents in connection with prayer for mutation of land in favour of Ess Dee Aluminium Ltd.


Ref: - His letter dated: 15.03.2024.

In connection with the captioned subject he is requested to submit the following documents

- 1) As per Xerox copy of Affidavit submitted earlier, it appears that the BIFR sanctioned the scheme of Merger of 'India Foils Ltd' with 'Ess Dee Aluminium Ltd' on 30.09.2010 with effect from 01.04.2008. The relevant documents of merger of the aforementioned entities issued by the BIFR are required.
- 2) As per para 3 in Affidavit, on 26.08.2022 Shakambhari Ispat & Power Ltd acquired the Corporate Debtor namely 'Ess Dee Aluminium Ltd' as a Going Concern by E- auction as a highest bidder. At this point it is not clear why petition has been submitted to mutate the land in favour of 'Ess Dee Aluminium Ltd' instead of Shakambhari Ispat & Power Ltd.
- 3) From the documents attached herewith it appears that an area measuring 17.33 acres comprising of 62 plots of mouza- Hoera, J.L No-1 under the jurisdiction of the BL&LRO, Mogra Chinsurah was recorded in favour of 'India Foils Ltd'. It is not clear how a commercial unit has been running without conversion of the land. Whether any prayer of conversion was submitted earlier by the

concerned authority on behalf of 'India Foils Ltd'? If so, he is requested to submit the copy of the same and up to date rent receipt in respect of the land measuring an area of 17.33 acres.

- 4) From the Xerox copy of letter it appears that Jeetendra Kumar Pandey was authorised to liaise with the BL&LRO, Chinsurah-Mogra for registration and mutation of land for plot no- 1597,1598,1599,1600,1602, 1606,1610,1613,1617,1618,1664,1668,1677,1678,1680 ( fifteen plots only), but as per record it is revealed that there are 62 plots in Khatian no-760 recorded in favour of 'India Foils Ltd'. He is requested to submit the authorization letter afresh in original accordingly.
- 5) As stated verbally Shakambhari Ispat & Power Ltd is a group of companies. He is requested to provide the name of other units and address properly with relevant documents.
- 6) He is requested to submit the Affidavit in original.
