Building Map







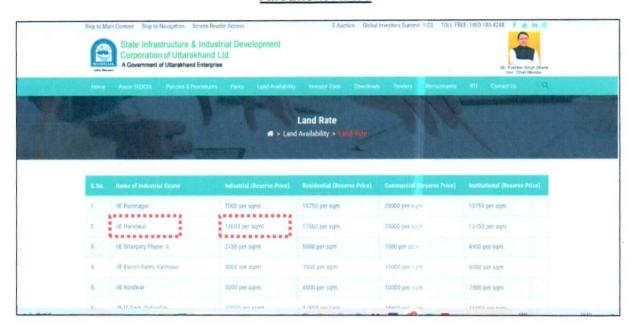
