Special Conditions issued to : M/s. Magpet Polymers Pvt. Ltd.(Unit-III)

A. Emission:-

- i. Hot Water Generator(Oil/Gas fired) to be provided with a stack of height 30m from G.L.
- ii.DG Set 1x63 KVA -to be provided with inbuilt acoustic enclosures and residential silencer and connected to stack of 4.5m above D.G.room.

Stacks to be provided with sampling port, platform and ladder as per the Emission Regulation Part – III of CPCB.

- B. **Effluent:-** 1.Process- to be treated in the proposed ETP and discharged to industrial park drain maintaining environmental standards.
 - 2.Domestic- to be discharged through septic tank/soak pit.

C.Solid Waste :- Plastic wastes to be disposed of as per the provisions of Plastic Waste Management Rules, 2016 and amendments thereafter.

D. General:-

- 1. The unit shall obtain EPR Registration as per the Plastic Waste Management Rules, 2016 and amendments thereafter.
- 2. The unit shall take proper measures to control air, water and noise pollution.
- 3. This NOC is valid only subject to obtaining permission/clearances from the other Competent Authorities as applicable.
- 4. The unit shall take adequate preventive measures to avoid fire hazard and obtain fire license from concerned authority.
- 5. No addition/alteration/modification can be done without prior permission from the State Board.
- 6. Good housekeeping to be maintained.
- 7. Adequate green belt in and around the unit to be developed.
- Necessary clearance to be obtained for withdrawal of ground water from the concerned Govt. Authority.
- 9. Rainwater harvesting arrangement shall be made.
- 10. The unit shall obtain Consent to Operate of the State Board before starting operation.
- 11. This NOC is valid upto 31.08.2030 for setting up the unit.
