- You shall be required to give one week notice to the office before starting the construction intimating the date of start the construction after taking the demarcation from the SDE, Survey Sub Division HSVP, Gurugram.
- 3. You shall be required to obtain a certificate verifying the correctness of the construction from the Survey Sub Division, HSVP, Gurugram II at plinth level, further construction should be done after receiving the above certificate.
- A set of plan duly approved is attached herewith.
- 5. The validity of building plans is for five years, subject to the condition that minimum construction should be completed as per HSVP Policy, otherwise the plot will be resumed under the HUDA Act and Rules.

NOTE :

- 1. The Fire fighting system must be installed as per Guideline of Director, Urban Local Bodies, Haryana. You will have to submit the Fire Safety certificate before taken the Occupation Certificate from Urban Local Bodies, Haryana.
- You will have to submit design of the building from the structural Engineer before starting the construction. Safety against seismis forces must also be taken in design.
- Provision of solar water heating system on the roof top should be provided.
- Provision of the Rain water Harvesting system recharge well/recharge borewell should be provided.
- 5. The D.P.C. certificate and P.O.C/O.C. certificate already issued will be deemed as cancelled after demolition of this portion for which P.O.C/O.C. has been issued and you will be required to take fresh D.P.C. Certificate and P.O.C./O.,C. certificate as per sanctioned Plan.
