

Brief Description of the Property Under Valuation

This opinion on Valuation report is prepared for the industrial vacant land situated at the aforesaid address. As per the copy of lease agreement dated – 29/07/2022, the subject land parcel of 25 acres which is a private land directly purchased from local villagers, is given on lease for a period of 90 years to M/s Globus Spirits Ltd. by M/s Odisha Industrial Infrastructure Development Corporation for the purpose of setting up of ENA/Ethanol manufacturing plant and 4MW power plant. The land area measured during site survey as per the knowledge of the representative is in line with the land area given in documents, so we have considered 25 acres for valuation assignment.



The subject industrial vacant land is irregular in shape, not demarcated by boundary walls, ~ 2 ft. below from the road level and is located in a very remote area

During site survey it was observed that one GF RCC structure is situated within the land area of 25 acres. The representative available from client's end confirmed that the structure belonged to the government earlier. However, we have not considered the same, as this is out of scope of this valuation assignment.

This report only contains general assessment & opinion on the Guideline Value and the indicative, estimated Market Value of the property of which Bank/ customer asked us to conduct the Valuation for the property found on as-is-where basis as shown on the site by the Bank/ customer of which photographs is also attached with the report. No legal aspects in terms of ownership or any other legal aspect is taken into consideration. Even if any

ENCLOSURE: V - COPY OF CIRCLE RATE





INDUSTRIAL ALLOTMENT RATE OF GUNDICHAPADA INDUSTRIAL AREA








