Demurrage Charges:

Installation Instructions:

Once the machine is unloaded the installation process shall resume. All the necessary material arrangements should be done as per the pre-installation report and should there be any short fall in the supplied list from Robus India than there will be delay in installation process. Robus India will not be responsible for the same.

Installation Period:

We shall provide on-sight installation and training to company staff for a period of 2 days.

Warranty:

Standard manufacturer warranty of 1 Year shall be applicable from the date of installation. All costs towards travelling, boarding & lodging of our engineer during this period shall be payable at actuals, or may be arrange by customer. No additional service charges shall be payable during warranty period apart from man-made problems and job trainings.

All parts required to be imported for warranty purpose shall be provided free of cost by manufacturer. However, all charges towards custom and local taxes shall be charged to the customer & shall become payable as the case maybe. All disputes subject to Noida jurisdiction only.

Transport Charges:

Once the machine reaches the factory, any delay in unloading the machine shall incur extra charges and shall be borne by the customer.



Late Payment Clause:

In case of payment not received on time, holding charges will be levied upon the buyer at the rate of 0.5% per week, from the ex-works date till the time machine remains in our stock. Without prejudice to the above, Robus India also reserves the right to divert the machine after two weeks of waiting period from the date of readiness of the machine and new delivery date will be communicated separately along with any other commercial implications.
