





ENCLOSURE: III - GOOGLE MAP LOCATION







For this land/ property survey report can be sought from a qualified private or Govt. This Valuation report is prepared based on the facts of the property on the date of the survey. structures, it is recommended that a Licensed Surveyor be contacted. 25.
