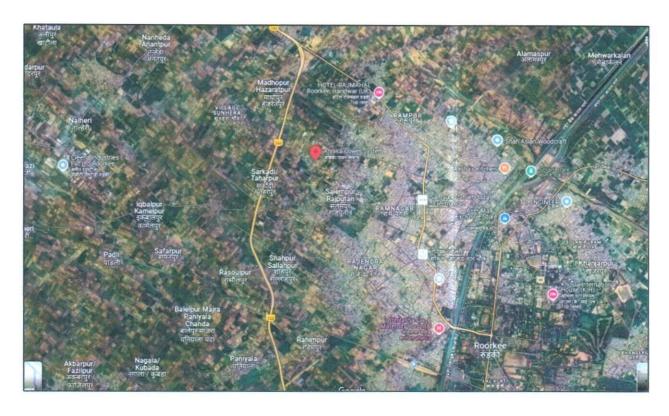








ENCLOSURE: III - GOOGLE MAP LOCATION









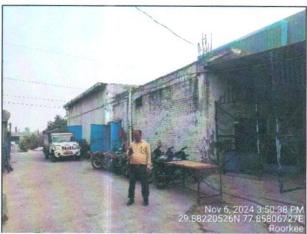

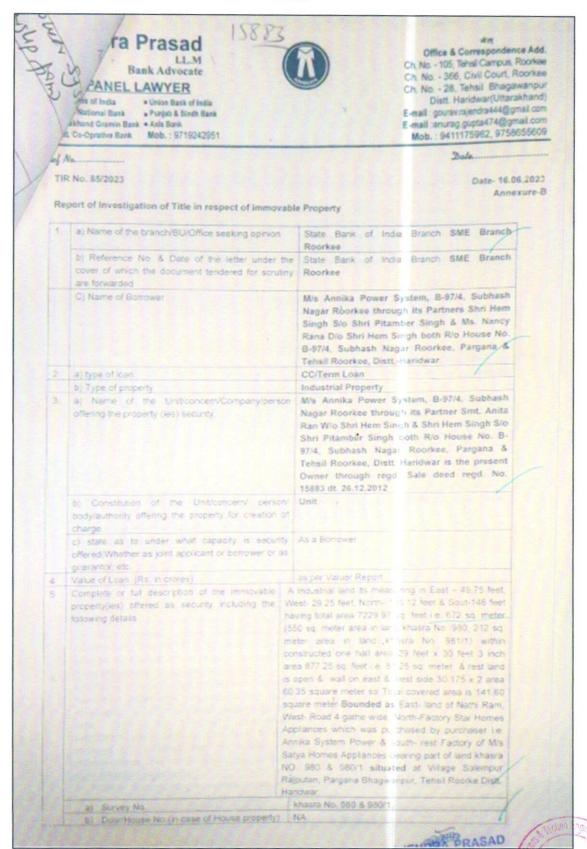

structures, it is recommended that a Licensed Surveyor be contacted.
