'CONSENT-TO-ESTABLISH' (NOC)

NOC UNDER SECTIONS 25/26 OF THE WATER (PREVENTION AND CONTROL OF POLLUTION) ACT, 1974 AND 21 OF THE AIR (PREVENTION & CONTROL OF POLLUTION) ACT, 1981

Reference application no.31733, dated 21.12.2010 & 3.3.2011 of M/S Tirupati Sugars Ltd, 202, Thapar Arcade, 47, Kalusarai, Hauzkhas, New Delhi-6 for Expansion of cane crushing capacity up to 7000TPD within the existing campus at Nariapur , Bagha, Dist – West Champaran (Bihar)

AFTER CONSIDERING:

(i) The facts stated in their application;

(ii) Bihar State Pollution Control Board's Notification No. 26 dated 08.11.2003;

(iii) Provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981;

NOC IN FAVOUR OF THE PROPONENT AT THE SAID SITE IS HEREBY ACCORDED SUBJECT TO THE FOLLOWING CONDITIONS:

- (i) The proponent shall obtain 'Consent-to-Operate' under sections 25 & 26 of the Water Act, 1974 and under section 21 of the Air Act, 1981 prior to commissioning of the plant with expanded capacity from this Board;
- (ii) The effluent (domestic or trade) and emission, if any, shall conform to the standard as prescribed by the Board;
- (iii) The D.G. Set(s) shall be installed with integral acoustic enclosure fixed on pucca base with anti vibration pads, and exhaust height maintained as per norms of the Board, so that, it shall conform to the standard of the Board. Accordingly submit Ambient noise level report to the Board just after commissioning of the unit.
- (iv) The unit shall obtain Environmental Clearance from Ministry of Environment and Forest Govt. of India before starting of expansion work
- (v) The unit shall submit scheme with T.B.P for installation of a New E.T.P for the treatment of industrial effluent.
- (vi) The unit shall install ESP/deducting equipment to control particulate emission.
- (vii) The unit shall construct new steel tank for the storage of molasses.



(viii) The unit shall install noise control equipments like as acoustic hoods, silencers, enclosures etc at all source of noise generation.

(ix) The unit shall provide port hole and platform in the stack ass per CPCB norms for flue gas measuring.

(x) The unit shall provide shed for storage of Bagass

(xi) Plantation in 5acors land shall be done and maintained.

(xii) The unit shall adopt Rain water harvesting measures to recharge the ground water.

(xiii) The unit shall provide fire fighting arrangements.

(xiv) The unit shall submit ground water monitoring report covering 1K.M Radius area from the unit to the Board.

(xv) The unit shall submit ambient air analysis report covering PM 10, SO₂ NOX and effluent analysis report covering pH, TDS, BOD, COD, Chloride, Sulphate, oil and grease and suspended solids to the Board before and after starting of production.

(xvi) The unit shall install STP for the treatment of domestic waste.

(xvii) After treatment of Industrial and Domestic Waste provision shall be made to recycle and reuse of total effluent.

(xviii) The unit shall not discharge their effluent out side of the command area.

NOTE:

 Bihar State Pollution Control Board reserves the option to revise or add other conditions, if necessary, for protection of Environment in general and for Pollution Control in particular;

 The present NOC should not be construed as an assurance for the grant of 'Consent-to-Operate' the proposed plant but shall be subject to compliance of all the conditions indicated above;
