With regard to the letters under reference on the subject mentioned above, it has been noted that the site of the above mentioned sugar mill is located at 27°7'55" N, & 84°4'34" E, which is outside the limits of Valmiki Tiger Reserve with distance to nearest boundary as 4.49 Km. It is 0.71 Km. from the nearest boundary of Eco-sensitive Zone (ESZ). Hence, the premises of TSL fall within 10 Km. from the nearest boundary of Valmiki Tiger Reserve. It is a Tiger bearing landscape.

Therefore, In pursuance of the Conservator of Forests-cum-Field Director, Valmiki Tiger Reserve, Bettiah recommendation vide letter no.-242 dated 17.02.2020 and distance of sugar mill from Valmiki Tiger Reserve, ESZ and WLS as calculated by the GIS Unit, IT Cell, Aranya Bhawan, Patna, No Objection Certificate is given with the following conditions:-

- Tirupati Sugar Ltd., (TSL), Nariapur, Bagaha, District-West Champaran (Bihar) shall abide by the Conservation Plan as given in the above referred letter of Conservator of Forests-cum-Field Director, Valmiki Tiger Reserve, Bettiah (attached).
- Control and prevention of noise pollution, air pollution, discharge of effluents, solid waste management and e-waste management shall be ensured by Tirupati Sugar Limited in consultation with Bihar State Pollution Control Board.



 - (i) Nature of Land required/Location of the Project:
 - (a) Tirupati Sugars Ctd (TSL) is located at N 27*7'55" & E 84*4'34", which is outside the limits of Valmiki Tiger Reserve and its Eco-sensitive Zone (ESZ) as have been notified vide Gazette Notification No. S.O. 3026 E dated 13th September, 2017- about 0.70 kms from the nearest boundary of ESZ. However, the premises of TSL falls within 10 kms from the nearest boundary of Valmiki Tiger Reserve.
 - (b) No additional land is being acquired for the purpose of expansion of the existing sugar mill and establishment of molasses based distillery project.
 - (c) No forest land is involved in this proposed TSL Project.
 - (d) There is no record of wildlife offences against TSL.
 - (ii) Adverse Impact anticipated on the environment due to the proposed expansion of TSL: TSL has submitted the Pre-Feasibility Report and the Environmental Impact Assessment Report with Environment Management Plan of the proposed expansion project. As per their letter dated 30.01.2020, noise pollution, air pollution, discharge of effluents, solid waste management and E-waste management are within the limits/ standards of the Environment (Protection) Rules, 1986 and other related Rules and Regulations. These aspects may well be adjudged by the Bihar State Pollution Control Board Officials/team

- (iii) Google Map of the Project area: Google Map of the Project Area of TSL with respect to Eco-Sensitive Zone of Valmiki Tiger Reserve is duly signed and enclosed.


