2. Current status of the Project. - All common infrastructure, plant and machinery is built for 10 TPD Capacity. As you are aware, initially, the promoter planned to implement the project in two equal phases, each with a capacity of 5 TPD. However, with the Government of India's enhanced policy support to bolster the CBG industry's prospects, the promoter was motivated to expedite the implementation of Phase-II. Recognizing this strategic opportunity, the promoter expanded the project scope to include the development of common infrastructure, plant, and machinery for the full 10 TPD capacity in one go. Importantly, this decision was made while ensuring that the commissioning timeline (DCCO) for Phase-I remained unaffected. To achieve this, the promoter infused additional funds from personal sources to cover the increased capital requirements.

Thus, at present company has incurred about 50% of the project cost of Phase-II and targeting to achieve COD for Phase-II within 12 months from the date of 1<sup>st</sup> disbursement of the Term Loan for Phase-II.

- 6. Statutory approvals / NOCs taken for the Project. The Phase-II project is being set-up on the same land and the approvals & clearances obtained are for entire 10 TPD, thus, no fresh Statutory approval/ clearance/ NOC is required separated for Phase-II.
- 7. Attach Bills / Invoices /POs / Contract Agreements with the vendors / Suppliers. Please find attached proposal received from Anaerobic Digester Vendor i.e. PlanET Biogas Global GmbH dated 30.09.2024 for your reference. As you may notice from the table in point no.5, rest of the capex line items are mainly related to AD only and not a significant amount. These minor packages will be negotiated and awarded in 1<sup>st</sup> 2 months from the Phase-II financial closure date.


