Thus, for Cost vetting related working, I break it down as follows:

1. Total Project cost for 10 TPD = Rs. 84.77 Cr
2. Cost incurred till 16.08.2024 = Rs. 62.77 Cr. (all details are being covered with above mentioned supporting docs)
3. Break-up of the balance ~Rs. 22 Cr. Is mainly divided into key 3 parts:
 - a. Building & Other Civil Works (~ Rs. 1.5 Cr.)
 - b. Plant & Machinery (~ Rs. 20.3 Cr.)
