AND WHEREAS the Regional Director filed an Affidavit on 19th January 2015 stating therein, save and except as stated, it appears that the scheme is not prejudicial to the interest of the shareholders and public.

AND WHEREAS the Honorable Court examined and considered the material on record and states that the Scheme Appears to be fair and reasonable and is not violate of any provisions of law and is not contrary to the public policy. Since all the requisite statutory compliances have been fulfilled, the Company Scheme Petition is made absolute in terms of prayer clauses (a), (c) and (d) of the Petition.

AND WHEREAS the Petitioner Company filed the said Order alongwith the Scheme of Amalgamation with the concerned Registrar of Companies along with concerned E-Form INC-28 as per the relevant provisions of the Companies Act, 1956/2013 and paid cost of Rs. 10,000/- to the Regional Director, Western Region, Mumbai and the Official Liquidator, High Court, Bombay.


