I am directed to refer to your letter dated 25.03.2021 on the subject cited above and to say that in view of the position explained therein, the Development Commissioner, SEEPZ-SEZ, approves your request for continuation of EOU status for a further period of five years from **2021-22 to 2025-26 w.e.f. 01.04.2021 to 31.03.2026** with Fresh Export/Import Projection i.e. Export Performance of Rs. 19,300/- Lakhs (US \$ 2,68,05,550/-), Import of Capital Goods is 'Nil', Import of Raw Material & Components Rs. 11,790/- Lakhs (US\$ 1,63,75,000/-), Import of Spares & Consumables Rs. 585/- Lakhs (US\$ 8,12,500/-) & NFE of Rs. 5,770/- Lakhs (US \$ 80,13,880/-) in terms of Para 6.05 of Foreign Trade Policy 2015-2020, read with Para 6.01 (i) of Handbook of Procedure 2015-2020.

2. This approval is subject to the following conditions: -

- The entire (100%) production excluding rejects and sales in the Domestic Tariff Area (DTA) as per provision of EOU Scheme shall be exported.
- The unit would be required to achieve positive Net Foreign Exchange (NFE) as prescribed in the EOU scheme for a period of five years failing which you would be liable for penal action.
