### Annexure-II

By observations the structure is safe and sound. Following points may please be noted and followed for further safety of structure.

- 1) Existing position and condition of equipment shall be maintained as per approved plan. Any change of vessel increases in loading should be checked before loading.
- 2) Any change in steel structure / member / addition alteration should be checked from structural engineer.
- 3) All RCC / steel structures shall be painted and well maintained regularly, maintenance report to be maintained.
- 4) Pressure vessel / reaction vessels should be checked periodically from competent person at regular interval. Temperature and pressure should be maintained within safe limit. Otherwise increase in temperature / pressure may cause damage to steel structure.
- 5) Any abnormal settlement of any part of steel structure should be reported immediately to structural engineer.
- 6) Any vibration on steel structure if observed should be reported immediately to structural engineer
- 7) Water logging near plinth level or steel column and RCC building should be avoided to prevent settlement of columns.
- 8) All structural members shall be protected from any type of acidic materials and shall be well protected from salinity. All acidic effluent shall be properly drained to safe place by providing proper drainage. So that flooring and structural member remains unaffected by such materials
- 9) Any addition alteration and change in equipment take place revised stability certificate should be obtained.
- 10) Structural inspection report of Structure Engineer to be Submitted, Every year.
- 11) Water seepage indication found at admin office first floor & second floor staircase, suggested to repair the same.
- 12) Revision drawing is suggested to get approved as per the site & approved map.

- Tests, examinations and inspections shall be carried out under the direct supervision of the competent person or by a person so authorized by an institution recognized to be a competent person.
- The certificate of competency issued in favour of a person shall stand cancelled if the person declared competent leaves the organization mentioned in his application.
- 4) The institution recognized as a competent person shall keep the Director, Industrial Safety & Health informed of the names, designations and qualifications of the persons authorized by it to carry out tests, examinations and inspections.
- 5) The copies of certificates of examinations / tests issued by you after due examinations / tests are to be marked to the Inspector of Factories concerned within seven days in all cases where defects are noticed and repairs or alternations are suggested on its use.
- 6) The record of the work done by the competent person should be maintained in the Log Book, incorporating therein the details regarding work done, observations made, directives given etc.
- 7) Certificate No. and validity period should invariably recorded by you in all the copies of certificates of examinations / tests signed and issued by you.
- 8) Every examination / test shall conform to the relevant standard, if it is not specified in the Act or rules made there under.
- 9) Facilities and equipments to be used by you should be maintained and kept in a good and efficient working conditions at all times and calibrated from time to time.
- 10) Application for renewal of Competent Person Certificate shall be made at least two months before the date of expiry of the certificate to the Director, Industrial Safety & Health with Log book for the period of previous nine months in case of first renewal and twelve months in case of second and subsequent renewal.

11) Save as provided in Rule 61(9)(a) of section 31, in no case conditional certificate shall be issued.
