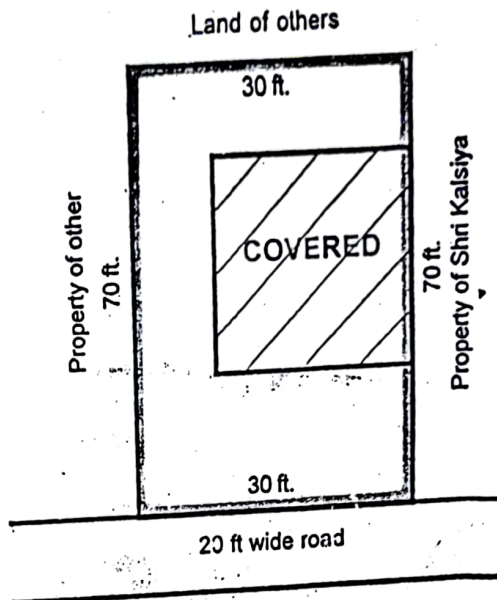
SITE PLAN OF DOUBLE STOREYED HOUSE CONSTRUCTED ON PART OF


