I. Scope of Work

- 1) Inspection of the project site located at Part of Khasra No. 11, Village Hardiya Bujurg, District Basti, Uttarpradesh.
- 2) Interaction with the promoters to discuss various aspects of the business such as their experience & competency, idea behind setting up the proposed project, their marketing strategy, functioning of the day-to-day business activities, etc.;
- 3) To ascertain the approachability of the land, availability of resources such as electricity, water, transport facility, raw material proximity, market proximity, etc.;
- 4) Prepare a video of the complete site visit and interaction with promoters;
- 5) Take pictures (with location/geo tagging) of the site and nearby vicinities.

II. Timelines

- a. Site visit to be conducted within 7 days from the date of this letter.
- b. The report duly signed by the person visiting the site should be submitted along with video recording site photos and Undertaking/Certificate as per Section 65(B) of Indian Evidence Act (format Enclosed Annexure A) within 7 days of the site visit and maximum within 15 days from the date of this letter or such time extended by IFCI Venture at it's role discretion.

III. Tenure and Fees

- a. Fixed professional fee of Rs.10,000/- (One Time) and GST would be paid for the said assignment.
- b. Out of pocket expenses such as travel, stay, etc. shall be reimbursed as per actuals on submission of bills.
- c. The professional fees of site visit including out of pocket expenses as mentioned at Clause a & b above, shall be borne by the concerned company/beneficiary only.

IV. Eligibility of Travel

The out-of-pocket expenses shall be to an extent as below:

- a. By Air: Economy class (if applicable);
- b. By Rail: AC Three Tier;
- c. BY Road: Car;
- d. For stay: up to 3 (three) star hotel (if required);
- e. Out of pocket expenses shall be reimbursed on actual basis.

V. General Terms and Conditions

a. If any information/act is found to be detrimental/prejudice to the interest of IFCI Venture based on the prescribed assignment requirement as specified above, IFCI Venture reserves the right to terminate the assignment of Adroit Technical Services Pvt. Ltd. at the instant time, or at any time thereafter as and when such information comes to the knowledge of IFCI Venture without any reasons. In such



- event the service provider shall not claim any fee after receipt of such information.
- b. Service provider shall not assign any work in part or total to any third party without IFCI
 - Venture's written consent under this agreement.
- c. Service provider shall make efforts to protect interest of IFCI Venture at all times & also not violate any law /rules/regulations while acting as IFCI Venture's representative during the assignment.
- d. Jurisdiction: The jurisdiction for the purpose of settlement of any dispute of differences whatsoever in respect of or relating to or arising out of or in any way touching this contract or the terms and conditions thereof or the construction and/or interpretation thereof shall be that of the appropriate court in New Delhi only. The jurisdiction of any other court in any place other than New Delhi is specifically excluded.
- e. Confidentiality: Entity will carry out the assigned services in mutual trust and in confidentiality. You will not leak or part with any information related to the above to any other party or make use of the said information for any illegal gain.
