The captioned company has been issued Letter of Comfort (LoC) dated 14.11.2018 (photocopy enclosed) for setting up an Automatic Steel Rolling Plant through steel melting/ steel casting and then Rolling Plant having installed capacity of 3,60,000 mtpa each for manufacture of MS Billets and TMT Steel Bars/Angle/Channel/Wire Rods etc. in two phases with a capital investment of Rs. 183.75 crores at Bulandshahr (Paschimanchal Region), vide which various facilities/incentives were recommended.
